Tournament Rules:-

System of Play: The Tournament will be conducted as per FIDE Laws of Chess & FIDE Swiss System with 10 Rounds.

Time Control :- 90 Minutes + 30 Seconds Increment from move No. 1

Tie Break: - In case of tie, the latest FIDE Rules shall be come in to effect. The Cash Prizes however will not be shared.

Protests: Protests, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee Rs. 1000/- within 30 minutes of the occurrence of the incident to the appeals committee. The Protest fee will be refunded, if the appeal is upheld.

Appeals Committee: Before the commencement of the tournament, a five - member committee of appeals with two reserves shall be formed by the organizers. All members and the reserves shall be from the different states. No member of the committee can vote on dispute in which a player from his own state is involved and such in cases the reserves (s) shall take his place in the committee. The decision of the Appeals Committee is FINAL and BINDING on all players.

AICF Registration & The HCA Registration :- AICF and the HCA Registration (For Haryana Players only) Will be Compulsory for all players for the 2018-19. **On the spot AICF Registration will not be done.** Players must registered with AICF through website given below with a fees of Rs. 250/-. The registration facility for HCA will be available at the venue on the payment of Rs 200/- .Players should bring one passport size photograph and 2 xeros copies of birth certificate. **E-mail ID of the player is compulsory**

Note - All the players should compulsorily register themselves on WWW.AICF.IN In Otherwise case, The Organizers shall not be responsible for any sort of discrepancy or failure in tournament participation

Accommodation & Food :- All Player's will be provided with free AC Accommodation on sharing basis & Food. The Accompanying Person shall be charged Rs. 3,000/- (Three Thousand) for the entire Duration of the tournament.
