TOURNAMENT RULES

Eligibility : Only the players of Tripura are eligible to participate in this event .

Entry Fees : Normal entry Rs.500/-

LAST DATE OF ENTRY : 03.05.2018. Rs.300/- will be collected as late fee for entries received after 03.05.2018., however no entry will be entertained after 08.05.2018. All entry fees should be remitted by Demand Draft payable at Udaipur favouring Udaipur Chess Association , UCO Bank, Udaipur Town Branch, Udaipur – 799120 or may be deposited through NEFT to our Bank A/C with UCO Bank, Udaipur Town Branch, A/C. No. 21210110012208 , IFSC : UCBA0002121 , Name of A/c. Udaipur Chess Association, Type of A/c: Savings and an intimation to be sent by email to arbiterpkroy@rediffmail.com

Lodging : Dormitory lodging will be provided to all players free of charge. All other accompanying persons should make their own arrangement for their stay.

Registration : AICF registration fees of Rs.250/- for the year 2018-19 is compulsory for all participants (exempt for those already paid this year if proof shown) and will be accepted at venue. ATCA (All Tripura Chess Association) registration is compulsory for all the players of Tripura.

Appeal Committee : The organizers will form an **Appeal** committee for the smooth conduct of the **AKHIL SMRITI 44 TH TRIPURA STATE FIDE RATING CHESS CHAMPIONSHIP 2018**

System of Play : The Championship will be played under FIDE's Laws of Chess and the Swiss system. Totally nine rounds shall be played .

Default Time : Default time for arriving to the chess board is 15 minutes.

Session : The rate of play shall be 90 minutes with an increment of 30 seconds per move from move No. one.

Chess Clocks : All players are requested to bring their own chess clocks .

Tie Break : Direct encounter , Buchholz cut 1, Buchholz and Sonneborn Berger , the greater no. of wins tie break system will be applied. In case of tie , cash prizes will not be shared.

Appeals Committee : Before the commencement of the tournament, a five member committee of Appeal with two reserves shall be formed from amongst the senior participants present at the Manager's meeting to be held at the venue on the Inaugural day . No member of the committee can vote on a dispute in which a player from his own Sub-division is involved and in such case the reserve member(s) shall take his place in the committee.

Protest : protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.500/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.

Disqualification : No participant will leave the venue before the Prize Distribution function without the permission of the Chief Arbiter. The participants disregarding this rule are liable to be placed under suspension for one year.

Interpretation : For interpretation of the rule(s) and deciding any point not covered by the above rules of the tournament, the decision of the Tournament Committee shall be final and binding on all. The Tournament Committee has every right to make any addition or amendment to these rules, without notice. Such changes will, however, be displayed in the tournament hall.
