**Tournament Committee:** The organizers will form a tournament committee for the smooth conduct of the tournament.

**Rules & Regulation:** Tournament shall be played according to Fide Rules , Swiss System and Fide Laws of Chess shall be applicable ,

**Default Time:** 15 Minutes

**Time Control:** 90 Minutes + 30 Second increment per move, starting from move no. 01

**Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1,000/- within 30 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.

**Appeals Committee:** Before the commencement of the tournament, a five member appeals committee shall be formed by Organizers. All the members and reserves shall be from different states. No member of the Committee can vote on a dispute in which a player from his own State is involved and in such case(s) the reserve member(s) shall take his place in the committee.
