Entry fee and registration

FREE: GM, IM, WGM & WIM players and above Rating above 2300

Rs.250/- for all players

Last date of entry is 23rd July, 2019. However entry will be accepted till 26th July, 2019 with a late fee of Rs. 100. No entry will be accepted after 5 pm of 26th July, 2019.

After completion of payment, an email with filled up entry form & proof of payment should be sent to guwahatichessassociation@rediffmail.com. Verbal or telephonic entry will not be entertained at any cost. Organizers reserve the right to reject any entry without citing any reason whatsoever.

AICF Registration:

All participants in the rating tournament should be registered with AICF for the year 2019-2020. Online AICF Registration is available in the website www.aicf.in. Those who have paid the AICF Registration fee but are yet to receive the AICF Registration card should send a photo copy of the acknowledgment for having paid the fee to organizers of earlier tournaments or to their association. Before the championship all the players must be registered with AICF for the year 2019-2020. No entry will be accepted without AICF Player's Registration for 2019-2020.

AACA registration for 2019-20 is compulsory for Assam players.

Guwahati Chess Association registration for 2019-20 is compulsory for Guwahati players

System of Play:

The Championship will be played under FIDE Laws of Chess and total eight rounds shall be played

Default Time: Default time for arriving to the chessboard is 15 minutes.

Time Control: shall be 90 minutes + 30 seconds increment per move from move number one.

Tie Break: Following is the order of tie-break:

- (a) Direct encounter
- (b) Buchholz Cut 1
- (c) Buchholz
- (d) Sonneborn Berger
- (e) The greater number of wins (forfeit included)

Appeals Committee:

Before the commencement of the championship, a five member Appeals Committee shall be formed by the Organizers. All the members and reserves shall be from different states. No member of the Committee can vote on dispute in which a player from his own state is involved and in such case(s), the reserves shall take his/her place in the committee. The decision of the Appeals Committee is final and binding on players concerned.

Protest:

Protests, if any, against the decision of the Chief Arbiter, shall be made in writing with a protest fee of Rs. **1,000/-** within one hour of the occurrence of the incident. The amount shall be refunded if the appeal is upheld.

Interpretation:

For interpretation of the Rules and deciding any point not covered by Rules, the decision of the Tournament Committee shall be final and binding. The Tournament

Committee has every right to make any additional or amendment to these rules without prior Notice. However, such changes or inclusion will be subject to AICF clearance. Such changes, however, will be displayed at the Championship venue.

All players will be given certificate of participation. **It is mandatory for all the participants to attend the Inauguration and Prize distribution Ceremony.**
