AGE PROOF:

Birth certificate registered within one year of birth is compulsory for age group prize.

SYSTEM OF PLAY:

The tournament will be played under the FIDE Laws of Chess and Swiss system. Total 9 rounds shall be played unless otherwise decided by the Tournament Committee.

SESSION:

The format of play shall be 90 minutes for each palyer with an increment of 30 seconds per move from the starting move.

TIE-BREAKS:

Latest Tie Break system as approved by AICF & FIDE will be applied.

PROTEST:

Protest, if any, against the decision of the chief arbiter shall be made in writing with a protest fee of Rs.500/- within 30 minutes of the occurrence of the incident. The protest fees will be refunded if the appeal is upheld.
