- 1. The average annual turnover in the last three financial years ending March 2022. Mentioned at part II para 1(b) and Part IV 3.3 A1 to read as Rs. 3.00 Crore instead of Rs. 15.00 Crores. Accordingly, A1 (1) to be read as Rs. 3.00 Crore to 5Crore, A1 (II) as Rs. 5.00 crore to less than Rs. 7.00 crore and A1(III) more than Rs. 7.00 crore.
- 2. Part II Essential Details of Items / Services Rendered

Qualification requirements for participation may be read as

For Sn (a) - The bidder must have at least three years experience (ending month of March prior to the bid opening) of providing similar type of services

For Sn (e) - The bidder must have successfully executed/completed similar services (definition of "similar services" should be clearly defined), over the last three years i.e. the current financial year and the last three financial years: -

1) Three similar completed services costing not less than the amount equal to 40% (Forty per cent) of the estimated cost;

Or

2) Two similar completed services costing not less than the amount equal to 50% (Fifty per cent) of the estimated cost;

Or

3) One similar completed service costing not less than the amount equal to 80% (Eighty per cent) of the estimated cost

For Sn (g) Bid Security (also known as Earnest Money) is to be obtained from the bidders except Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department. The bidders should be asked to furnish bid security along with their bids. The EMD shall also be furnished via any online acceptable method (NEFT/RTGS) in addition to methods indicated in the RFP as per the following details (the Bidder has to submit a copy of UTR No. in case the transaction is done by this method);

4. Evaluation Methodology may be read as below:

Price Bid of only those bidders, who achieve a minimum benchmark score of 70 marks above would qualify for Financial Evaluation. The contract shall be awarded to the bidder whose Total price excluding GST will be the lowest (L1), and whose bid has been determined to be in full conformity to the bid documents. After the technical evaluation (quality) is completed, the federation shall notify those agencies whose proposals did not meet the minimum qualifying mark or were considered non- responsive to the RFP and Scope of work and the financial proposals of such bidders will be returned unopened after the signature of the contract.

Federation shall simultaneously notify the agencies that have secured the minimum qualifying mark, the date, time and place set for opening the financial proposals or as mentioned in the RFP, to enable the agencies to attend the opening of the financial proposals. The financial proposals shall be opened publicly in the presence of representatives of the agencies who choose to attend. The name of the agencies, the technical points, and the prices quoted shall be read out by federation. The contract shall be awarded to the bidder whose Total price excluding GST will be the lowest (L1), and whose bid has been determined to be in full conformity to the bid documents.

The successful bidder shall be the bidder having the Lowest quoted rate score i.e. L-1 bidder. In the event two or more bidder have same financial quote then , the bidder with higher/highest combined Technical score shall be considered as successful bidder. Bidders are required to spell out the rates of tax in unambiguous terms; otherwise their offers will be loaded with the maximum rates of duties and taxes for the purpose of comparison of prices. If there is a discrepancy between words and figures, the amount in words will prevail for calculation of price. Any other criteria as applicable to suit a particular case.
