## Election Procedures for Office Bearers (Term: 2024-2027):

As per the guidelines of the AICF Constitution and National Sports Development Code 2011, the following procedures are established for the election of Office Bearers for the term 2024-2027:

1. The Office Bearers will be elected through a Secret Ballot process. The entire election is to be video-graphed and photographed.
2. The AICF General Body will elect, by majority vote, the Office Bearers:
  - One (1) President,
  - Six (6) Vice Presidents
  - One (1) Honorary Secretary
  - Six (6) Joint Secretaries
  - One (1) Treasurer.

for a **three-year term**.

3. Every affiliated State/Union Territory Association is entitled to two (2) votes.
4. Each State/Union Territory Association shall be represented by two (2) delegates, who are duly elected members of their respective associations. The names of these delegates shall be communicated to President / Secretary of All India Chess Federation #101 First Floor A-Block Naurang House KG Marg New Delhi-110001 and the same shall be mailed to the Returning Officers i.e. Justice (Retd.) R. N. Pandey and Justice (Retd.) G. S. Sistani at their email addresses i.e. justicernp@gmail.com and sistanilaw@gmail.com, respectively, on the official letterhead of the respective State/Union Territory Association, signed by their President / Secretary.

5. For the elections of AICF, the President and Secretary of the member state association should be the representatives. In the event that either the President or the

Secretary are unable to represent a member state association, the member state association shall be represented by a member authorized by the President or Secretary General/Secretary of the affiliated Permanent Member State/Union Territory; however, in case President/Secretary General/Secretary nominate different person(s), then the person(s) authorized by the President shall be deemed to be the duly authorized person(s), irrespective of the date.

6. The names of the two (2) delegates (Along with Aadhar Card / Voter ID and Phone no. and email ID of each delegate) must be submitted to the All India Chess Federation office at #101 First Floor ,A Block Naurang House KG Marg New Delhi 110001 in New Delhi upto 3:00 PM on 23.02.2024, either physically or email, and copy to be marked to the Returning Officers. The list of delegate names shall be displayed in FORM 1 and will be available on the AICF official website on 24.02.2024 and communicated via email to the Returning Officers.

7. Nominations in Form 2 must be submitted to the Returning Officers between 11:00 AM to 3:00 PM on 25.02.2024 to 27.02.2024 in-person with proof of identification at #101 First Floor A Block Naurang House KG Marg New Delhi 110001. Only the official nomination forms provided by AICF will be considered.

8. The list of nominated candidates will be made available on 29.02.2024 in Form 3 on the official website of AICF.

9. Nominations will be scrutinized on 01.03.2024 at 10.45 AM, and valid nominations in Form 4 will be announced and communicated.
