TOURNAMENT RULES AND REGULATIONS

- 1. System of Play: The Tournament will be conducted as per FIDE Laws of Chess and FIDE Swiss System with 9 Rounds.
- 2. Time Control: 15 Minutes + 3 Seconds increment from move 1 for entire game.
- 3. Reporting Time: All players should Report at 9.00 am. Tournament First round will start at 9.30 am.
- 4. Tie Breaks: In case of a tie, The following Tie Break Rules will be followed
- i) Buchholz cut 1 ii) Buchholz iii) SB iv) Direct Encounter
- v)Greater number of wins (including forfeit points)
- vi) Greater number of wins with black
- 5. Appeals Committee: Before the commencement of the tournament, a five member appeals committee shall be formed by the organizers.
- 6. Protest: Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs. 1000/-within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is up held otherwise amount will be forfeited
- 7. AICF Registration for 2024-2025 is Mandatory for players willing to participate.
- AICF Registration should be done before registration of tournament.

- 8. For Maharashtra Players registration of MCA is Mandatory along with AICF registration.

- 9. Refund Policy: Entry canceled before 20th January will be refunded after that entry fees will not be refunded.
- 10. Interpretation: For interpretation of the rule(s) and deciding any point not covered by the above rules of the tournament, the decision of the Organiser shall be final and binding on all.
- The Organiser has every right to make any addition or amendment to these rules, without notice.
- However, such changes/ or inclusion will be subject to AICF clearance.
- 11. Withdrawal: If any player withdraws from the tournament need to inform Chief arbiter in writing.
- 12. Disqualification: No prize winner will leave the venue before the Prize Distribution function without the permission of the Chief Arbiter.
- Otherwise their prize will be forfeited.
- 13. Electronic Devices: Those who are having mobile phones/electronic devises or wearing watches during their play will be declared lost.
- 14. Accommodation: Players will have to make their own arrangement for stay.
