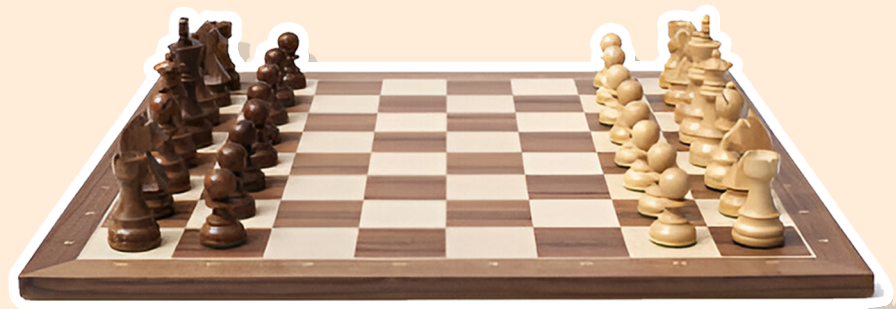

Rules & Regulations

- All players are eligible to participate
- **System of Play:** The Tournament will be conducted as per FIDE Laws of Chess and FIDE Swiss System with 9 Rounds
- **Time Control:** 10 Minutes plus 5 Seconds Increment from move, Default Time: 10
- **Electronic Devices:** All electronic items including wrist watches & Cell Phones (all type of watches) will not be allowed in the tournament hall
- Player qualified for more than one prizes will be considered only for higher prize
- **Tie Break:** In case of tie, following criteria would be used descending order
Buchholz cut 1 • Buchholz • Sonneben Berger • Direct Encounter • Greater no of victories. • No of wins by Black
- In case of any dispute, Chief Arbiter's decision will be final and binding on all
- **APPEALS COMMITTEE :** A 5-MEMBER APPEALS COMMITTEE (WITH 2 RESERVE) WILL BE FORMED THE PLAYERS' MEETING BEFORE THE START OF EVENT
- **PROTEST :** ANY PROTEST AGAINST THE DECISION OF CHIEF ARBITER SHALL BE MADE IN THE WRITING WITH THE FEE OF RS. 1000 WITHIN THE 15 MINUTES OF INCIDENT. PROTEST FEE WILL BE REFUNDED IF THE APPEAL IS UPHOLD. THE DECISION OF APPEALS COMMITTEE IS FINAL AND BINDING TO ALL
- The organizer will reserve the rights to admit or refuse any entry without assigning any reason They also reserve the rights of admission to the venue

Refund : Entry fees will be refunded after deduction of administrative charges of Rs. 300 after the tournament is over. After the pairing of first round entry fees will not refunded
