### TOURNAMENT RULES & REGULATIONS

- REPORTING TIME: 08:30 AM
- PLAYERS' MEETING: 09:00 AM
- ROUND 1 BEGINS: 10:00 AM
- DEFAULT TIME: 15 MINUTES
- TOTAL ROUNDS: 10 (SUBJECT TO THE DISCRETION OF THE CHIEF ARBITER)
- ENTRY FEE: NO REFUND OR CARRY-FORWARD (CONDITIONS APPLY).
- ENTRIES: SPOT ENTRIES OR LATE ENTRIES WILL NOT BE ACCEPTED.
- PLAYING EQUIPMENT: CHESS SETS AND CLOCKS WILL BE PROVIDED BY THE ORGANIZERS. PERSONAL SETS ARE NOT PERMITTED.
- SYSTEM OF PLAY: SWISS SYSTEM, FOLLOWING THE LATEST FIDE RULES.
- PRIZES: PLAYERS ELIGIBLE FOR MULTIPLE PRIZES WILL RECEIVE ONLY ONE <u>HIGHEST PRIZE</u>.
- MERIT CERTIFICATES WILL BE GIVEN TO ALL PRIZE WINNERS ON STAGE.
- PARTICIPATION E-CERTIFICATES WILL BE AVAILABLE ONLINE WITHIN ONE WEEK.
- PLAYERS AND PARENTS MUST ARRANGE THEIR OWN FOOD & ACCOMMODATION.
- THE ORGANIZERS RESERVE THE RIGHT TO REJECT ANY ENTRY WITHOUT EXPLANATION.
- PLAYERS MUST BE PRESENT AT THE PRIZE DISTRIBUTION CEREMONY TO RECEIVE THEIR PRIZE.
- WITHDRAWALS MUST BE SUBMITTED IN WRITING TO THE CHIEF ARBITER.
- CASH PRIZES WILL BE TRANSFERRED ONLINE AFTER ONE WEEK. (UPI ID / GPAY / BANK ACCOUNT DETAILS REQUIRED).
- PLAYERS ARE ADVISED TO CARRY THEIR OWN WATER BOTTLES (DRINKING WATER WILL BE AVAILABLE AT THE VENUE).

## ADDITIONAL RULES

- TIE-BREAK: BUCHHOLZ TIE-BREAK SYSTEM WILL BE FOLLOWED. NO PRIZE SHARING IN CASE OF A TIE.
- DRAW: A DRAW SHALL NOT BE AGREED BEFORE BLACK'S 30TH MOVE, WITHOUT THE CONSENT OF THE ARBITER.
- PROTEST:
- ANY PROTEST AGAINST THE DECISION OF THE CHIEF ARBITER MUST BE SUBMITTED IN WRITING WITHIN 10 MINUTES OF THE INCIDENT.
- A PROTEST FEE OF RS. 1000/- MUST ACCOMPANY THE SUBMISSION.
- THE FEE WILL BE REFUNDED IF THE APPEAL IS UPHELD.
- APPEALS COMMITTEE:
- A FIVE-MEMBER APPEALS COMMITTEE WILL BE FORMED BY KSCA/ORGANIZERS BEFORE THE COMMENCEMENT OF THE TOURNAMENT.
- ALL MEMBERS (INCLUDING RESERVES) SHALL BE FROM DIFFERENT DISTRICTS.
- A MEMBER CANNOT VOTE ON DISPUTES
  INVOLVING A PLAYER FROM HIS OWN DISTRICT.
  IN SUCH CASES, THE RESERVE MEMBER WILL
  TAKE HIS PLACE.
